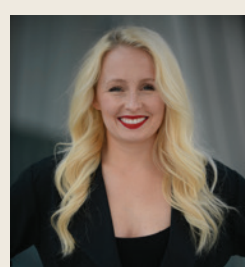

Butcher & Rose is a destination in the heart of Columbus, offering a respite from the city rush. Designed by Chicago-based Knauer Inc., guests enter into a romantic glow of light reflected in rich brass accents and awe-inspiring architecture of the historic building. Climbing floral pillars complement the warm, walnut coffered ceiling and rhubarb accents. The walls are filled with eye-catching art, all crafted by women artists including a 35-foot mural hand painted by local artist, Ellen Knolls. Notably, the four-season Pavilion boasts more than 50 seats, including a bar, and offers the most unique outdoor dining experience in Columbus. Guests will be transported to another place entirely beneath the glow of the lights through hanging greenery and a central tree to anchor the space, overlooking Broad Street and Preston Centre's sunken garden.
